- And to create employment opportunities for our members.





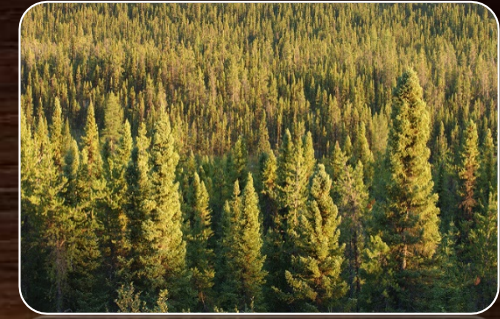
History

- Eenatuk Forestry Corporation was established in February, 1987
- Eenatuk was mandated by the Council of the Cree Nation of Mistissini to undertake all forestry related activities on Cat. 2/3 Land in the traditional territory of Mistissini based on historical agreements and Category 1 land through five-year forestry management plan commitments from the Cree Nation of Mistissini.
- Eenatuk became a subsidiary of the Eskan Company in 2002.
- Eenatuk is wholly owned at 100% by the Eskan Company.



Operations/Services

- Eenatuk Forestry offers a diverse range of services:
 - Harvesting, Road Construction.
 - Land Clearing/Slashing.
 - Scarification, Sylvi-cultural Projects.
 - Forestry Camps.



Timber Allocation

- Quebec Government makes available 350,000 cubic meters of timber to Cree Enterprises of Eeyou Istchee on an annual basis in Category 2/3 Land.
- As such, Eenatuk Forestry receives a guaranteed timber allocation of 125,000 cubic meters on an annual basis.
- Additionally, Eenatuk Forestry receives approximately 34,000 cubic meters of wood in Category 1 Land, pending and subject to a 5 Year Management Plan.
- The Members of the Cree Nation of Mistissini are required to accept and approve the 5 Year Management Plan.

Challenges

- The attempt to balance the economics benefits and environmental concerns is an ongoing concern.
- The focus on employment and sustainable job creation through training, lack of skilled individuals.
- The focus to safeguard cultural, spiritual and biologically important ecosystems.
- Integrating modern day land and resource activities while maintaining Cree traditions and land use.

Strategic Partnership

- We have a collaborative partnership with Chantiers Chibougamau.
- Agreement entails:
- Engage and direct recommendation of competent and qualified Cree local business in all operations.
- Transfer of knowledge (harvesting, road access and transportation operations) to Cree contractors.
- Provide access to engineering and certification expertise.
- Train a Cree employee for supervision and strategic field coordination.

Conclusion

- Eenatuk Forestry will in the near future be rebranded and diversify its operations into mining, environment and resource development.
- Our strategy is not always about economic returns, but in preserving the territory that we work in.
- These are our traditional territory, and an environmental conscious focus is a priority.
- We are a proud local employer with modest beginnings.
