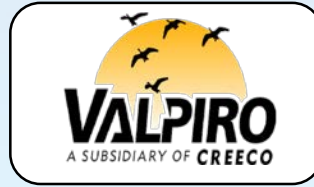
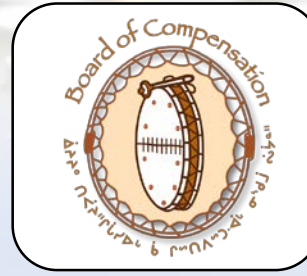

Dumas Contracting Wins Atlas Copco Trophy

- In July 2016, CREECO Dumas Mining Inc. signed a contract for development work at Goldcorp's Éléonore mine.
- Dumas **has achieved a milestone of over 645 days with a score of "000" – no recordable injuries** since the beginning of Dumas' development work at Éléonore in 2016.

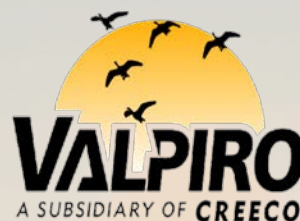
